Y. V. Reddy served as Governor of the Reserve Bank of India from 2003 to 2008. Prior to being the Governor, he was Executive Director for India, Sri Lanka, Bangladesh and Bhutan at the International Monetary Fund. He is currently Emeritus Professor at the University of Hyderabad.

Dr Reddy is a member of the Advisory Board for the George Soros-backed Institute for New Economic Thinking (INET), and is an Honorary Fellow at the London School of Economics and Political Science (LSE). He was previously a member of the Commission of Experts of the President of the UN General Assembly on Reforms of the International Monetary and Financial System, and a Guest of the Committee on Global Thought at Columbia University, New York.

He was presented with the 'Hall of Fame' award at the Outlook Money NDTV Profit Awards in October 2009, and the 'Outstanding Contribution to India' award at the CNBC-TV18 India Business Leader Awards in December 2009.
